

## EXPATS IN SPAIN.eu

### TERMS AND CONDITIONS FOR ADVERTISERS

#### General

1. Advertising will be removed from the website [www.expatsinspain.eu](http://www.expatsinspain.eu) six (6) weeks from the date of the invoice when payment is not received. Advertising on the Expats in Spain online magazine will not be published if payment is not received two (2) days prior to publication on the first of the month.
2. Invoices are payable with immediate effect from invoice date. Advertisements that have not been paid after six (6) weeks will be removed from [www.expatsinspain.eu](http://www.expatsinspain.eu) and will not be reinstated until payment is received. Prices published by Expats in Spain.eu from time to time are subject to revision at any time and orders are accepted on the condition that the price binds Expats in Spain.eu only in respect of the period specified in the applicable rate card. Once an advertisement has been added to the website that it has been invoiced for and has been paid, the advertisement cannot be cancelled and there will not be any refund of monies paid.

#### Online Advertising

3. All Advertisements accepted for publication by Expats in Spain.eu in any of its online sites is accepted subject to these terms and conditions. Any other conditions proposed by the buyer shall be void unless accepted by Expats in Spain.eu in writing. In these conditions: "Advertiser" means the person whose goods or services are advertised; "Advertisement" means display, recruitment, online, email, mail order and classified advertising and shall include inserts, supplements and re-directed advertisements; "Buyer" means the person placing the order for the insertion of the advertisement; "Medium" means the print or online publication taking the booking. " Expats in Spain.eu site" means the Expats in Spain.eu website onto which an advertisement is sold.
4. All Advertisements are accepted subject to space being available in the medium.
5. Expats in Spain.eu reserves the right to cancel any order or part of any order without liability and will refund any part of any cancelled order remaining. Expats in Spain.eu in the event of becoming aware of any meetings of creditors, bankruptcy, liquidation proceedings, the appointment of a receiver or administrative receiver over the whole or substantial part of the Buyer's assets, or any indication whatsoever of financial difficulties.

6. The Buyer agrees at all times in its conduct of business with or on behalf of Expats in Spain.eu strictly to comply with all applicable laws, ordinances, codes, regulations, standards and judicial and administrative orders.

Buyer agrees not to accept any payment or other benefit in money or in kind from any person as an inducement or reward for any act or forbearance or in connection with any matter or business transacted by or on behalf of Expats in Spain.eu. Delivery and Ownership of materials

7. Materials delivered must conform to Expats in Spain.eu specifications. Expats in Spain.eu reserves the right to charge the buyer for work it required to amend materials to conform to its specifications but accepts no liability for such work.

8. Any intellectual property rights in designs prepared by Expats in Spain.eu shall remain the property of Expats in Spain.eu and advertisements including such designs may not be reproduced without Expats in Spain.eu consent.

### **Booking procedures**

9. If an advertisement includes a promotion, competition or a special offer of merchandise the advertiser must provide full details to Expats in Spain.eu. Prices and Payment terms

10. The Buyer must deliver complete creative content to Expats in Spain.eu in a format which complies with Expats in Spain.eu online ad formats for such content. To cancel or alter an order the Buyer must inform Expats in Spain.eu by e-mail.

11. If the Buyer is supplying creative content or change of creative to be used in rotations, in the form of a redirected advertisement, the buyer must inform Expats in Spain.eu in advance.

12. If an Advertisement links to another site, the buyer is responsible for maintaining the link and for the content of the linked site. Expats in Spain.eu may remove any advertisement which contains content or links to a site which, in Expats in Spain.eu opinion, is defamatory or objectionable or will bring Expats in Spain.eu into disrepute. The buyer will indemnify Expats in Spain.eu from and against any claims or liability arising from links contained in an advertisement.

13. Advertisements may contain only such information and code as is necessary to run the advertisement effectively on the relevant Expats in Spain.eu site. Advertisements may not contain tags, cookies, beacons or similar technology which identifies users or enables the buyer or any third party to serve such users with any advertising other than the advertisement.

14. If an advertisement is supplied which does not comply with these terms and conditions or Expats in Spain.eu receives complaints regarding an advertisement, Expats in Spain.eu may, at its discretion, remove the advertisement from display without reference or liability to the buyer.
